The Notice of Postal Ballot was sent to the members, whose name appeared on the Register of Members/List of beneficiaries as on cut-off date i.e. 11th April, 2025.

As stated in sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014, as amended, advertisements were published by the Company in "Makkal Kural" in Tamil ("the vernacular Language") and "Business Standard" in all edition in English on 16th April, 2025 confirming completion of dispatch of Notice of Postal Ballot/E-voting information by e-mail.

The Company has appointed Central Depository Services (India) Limited ("CDSL"), the service provider, for providing the facility of remote e-voting to the Members of the Company.

The e-voting period remained open from Wednesday, 16th April, 2025 at 10:00 A.M. (IST) and ended on Thursday 15th May, 2025 at 05:00 P.M. (IST) on the designated website of Central Depository Services (India) Limited ("CDSL").

Particulars of votes cast through electronic means only have been entered in the register separately maintained for the purpose.

The Votes cast through electronic means were unblocked after the e-voting module was disabled by Central Depository Services (India) Limited ("CDSL"), on Thursday, 15th May, 2025 in the presence of two witnesses who are not in the employment of the Company. The data was scrutinized by me for verification of votes cast in favour and against the Resolution.

Votes cast through electronic means up to 05:00 P.M. on 15th May, 2025 being the last time and date fixed by the Company for voting through electronic means were considered for my scrutiny.

Since, there was no voting by physical ballot form, the question of keeping the physical postal ballot under my safe custody before commencing the scrutiny, reporting on number of envelopes containing postal ballot form received after due date and upto the date of this report, reporting on number of envelopes containing postal ballot form returned undelivered and reporting on finding of defaced or mutilated ballot paper, does not arise.
